PROVINCE OF NUEVA VIZCAYA**

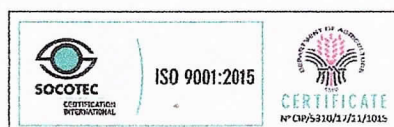

As such, he is expected to perform the duties and functions of his designation and to assist in the efficient implementation of the said program in the province.


