9. Bid opening shall be on **July 15, 2025 @ 1:30 P.M** at **Administration and Training Center Building Conference Room - DA RFO 02, San Gabriel, Tuguegarao City, Cagayan**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
