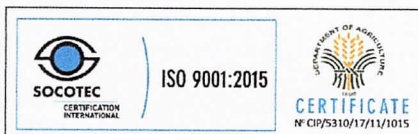
**Subject: DESIGNATION OF MUNICIPAL LOCAL GOVERNMENT UNITS

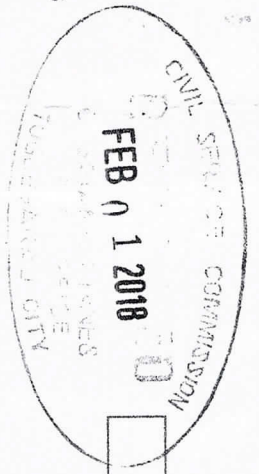
