

This order shall take effect from July 1, 2021 and shall remain in force until revoked in writing.

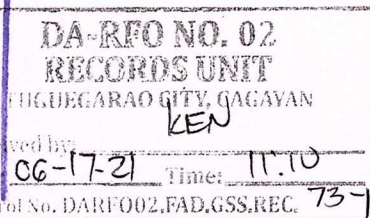
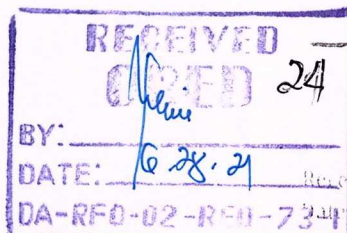
