

SUBJECT: DESIGNATION OF AGRICULTURAL EXTENSION WORKER (AEW) TO IMPLEMENT THE LIVESTOCK PROGRAM IN THE MUNICIPALITY OF CAMALANIUGAN, CAGAYAN

In the best interest of service and pursuant to the Memorandum of Agreement (MOA) between the Department of Agriculture Regional Field No. 02 (DA RFO 02) and the Local Government Units (LGUs), **Mr. Lazlo O. 




