**Subject: DESIGNATION OF PROVINCIAL LOCAL GOVERNMENT UNITS STAFF TO IMPLEMENT THE RICE PROGRAM**

\*\*\*\*\*

Pursuant to the Memorandum of Agreement executed between the Department of Agriculture Regional Field Office No. 02 (DA RFO 02) and the Provincial Local Government Units (PLGUs), **MR. ABSALOM RIZAL D. BAYSA** of the province of Nueva Vizcaya is hereby designated to work under Rice Program of DA RFO 02.

As an Acting Provincial Agriculturist, **Mr. Baysa** shall perform the duties and responsibilities inherent to his designation but are not limited to the following:

1. Prepare and submit Rice Industry Development Plan as a basis for program implementation in the province;
2. Supervise the distribution of agricultural inputs to farmers;
3. Facilitate and encourage farmers in profiling, registration and updating of farmer records in the Registry System for Basic Sectors in Agriculture (RSBSA);
4. Promote appropriate agricultural technologies to farmers either through technical briefing, seminars, or trainings;
5. Supervise the conduct of technology demonstration on rice-based farming systems;
6. Supervise the grouping of farmers into clusters, and strengthening of farmer cooperatives and associations in the different municipalities;
7. Coordinate with other National Government Agencies for the development of the local rice industry;
8. Supervise and monitor the conduct of pests and disease surveillance, early warning and control in the different municipalities;
9. Facilitate and encourage farmers in applying crop insurance, and non-crop agricultural insurance to the Philippine Crop Insurance Corporation, and facilitate claiming of indemnification; and
10. Review accomplishment report, planting, harvesting report, standing crop, and damage report as the need arises to DA RFO 02.

Relative to this, **Mr. Baysa** shall be entitled to incentive allowance based on the guidelines formulated by the Department of Agriculture Central Office.

This shall take effect on July 1, 2022. All orders inconsistent herewith are deemed revoked.
