
Subject: **DESIGNATION OF MR. JAYSON R. PATTONG AS CORN TECHNICIAN

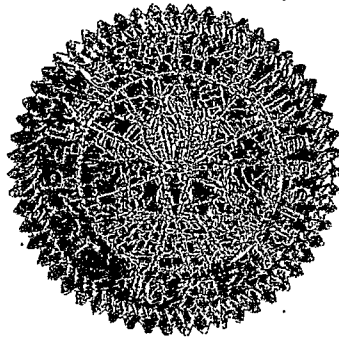



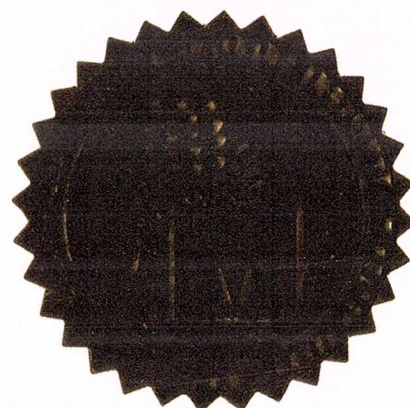
