

Functions/Responsibilities:


1. Participate in the planning, implementation, monitoring and evaluation of the livestock projects/programs and activities.

6. Attend meetings, conferences and perform other related activities.

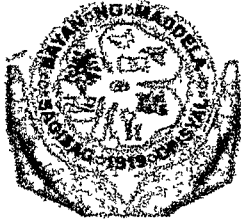
